# Adoption of Amended and Restated Bylaws

# New Article 2; Section 13 Director Emeritus

Section 13. Director Emeritus. Director Emeritus board members shall be permanent, non-voting, Board members recommended by the Nominating Committee and elected by a super-majority (as defined herein) of voting members present at the Annual Meeting.

Directors Emeritus must meet the following characteristics to be considered: i) served on the Board with distinction for five (5) or more contiguous years; ii) held key leadership positions or made significant contributions to the success of Orlando Ballet; iii) engaged in major volunteer or advocacy activities in service to the Board; and iv) served as an exemplar of Board service to Orlando Ballet. Directors Emeritus shall be entitled to receive all written notices and information provided to the Board, and to attend all meetings of the Board and Committees on which they serve. Directors Emeritus shall serve as continuing advocates for Orlando Ballet and advisors to the Board and staff as needed.

The Board may remove Directors Emeritus in accordance with the Article II, Section 6 (Removal) herein.

### New Article 4; Section 8 Immediate Past President

Section 8. Immediate Past President. If recommended by the Nominating Committee and elected by a super-majority (as defined herein) of voting members present at the Annual Meeting, the Immediate Past President shall be a Board member who served the prior fiscal year as President and shall serve a one-year term to counsel and advise the President and Board to facilitate effective transition of leadership.







#### **2019 DUSA AVERAGE**




### **2023B BUDGET (\$MM)**





### **ORLANDO BALLET FY22E (\$000)**




