


Generosity Fuels Growth

- 8% growth in contributed income over FY22; almost 500% growth since FY17
- Approximately \$100k from new donors through the United Arts Campaign this year
- Average gift amount increased from \$800 in FY17 to \$1,460 in FY23 with significant growth at \$5,000+ and \$10,000+ donor level
- The Ballet Ball continues to net over \$400,000 annually
- The Board continues to grow by size as well as generosity with a 38% increase in giving over FY22
